Description

Tobacco use is the leading preventable cause of death and illness in the United States . Apart from smoking tobacco, smokeless tobacco and secondhand smoke exposure cause additional morbidity and mortality. Three overarching principles of the AAP Policy Statement, Tobacco Use: A Pediatric Disease, include: (1) There is no safe way to use tobacco. (2) There is no safe level or duration of exposure to secondhand smoke. (3) Individuals, organizations, and government can use their financial and political power to support tobacco control and advocate for a tobacco-free world.

Pediatricians and their staff can use their unique position as they care for children to:

- Help patients and families with the prevention and/or treatment of tobacco use and secondhand smoke (SHS) exposure.
- Advocate for policies that protect children from SHS exposure and eliminate tobacco use in the media, public places, and

3-Step AAP CEASE Model [graphic2]

This EQIPP course presents a simple and memorable tobacco control model called CEASE to routinely and effectively address family tobacco use and exposure.

Step 1, Ask, screens families for tobacco use and SHS exposure in the home and car and asks tobacco users what they need to help them quit. It educates families about the harms of tobacco use and SHS exposure.

Step 2, Assist, motivates and presents options proven to be effective to help tobacco users quit. The combination of counseling and medication is more effective for smoking cessation than medication or counseling alone. Pediatricians can help families tap into free, state-funded tobacco quit line services to supplement their counseling efforts to help tobacco users quit or cut down.

Step 3, Refer, helps tobacco users develop a specific quit strategy that includes follow-up contact.
