- **Prostate Cancer Decision: Making the Best Decision Web Aid:** This website includes audio and interactive features designed to provide information on prostate cancer screening for men aged 50–70.
- Instructions for Using the Prostate Cancer Decision: Making the Best Decision Tool: This one-page sheet provides website users with information on how to access the web aid and contact information for questions on how to access the web aid.
- Troubleshooting for Web Decision Tool: This two-page sheet summarizes potential technology issues using the web aid and how to resolve the issues.
- **Internet Access Locations in the DC Metro Area:** This one-page resource sheet is a listing of Internet access locations. The sheet can be customized to any geographic location.
- **NCI Decision Aid Letter:** This is a one-page template designed to introduce the decision aid to interested participants by email or postal mail.

#### **B. Program Implementation:**

The steps used to implement this program are as follows:

- Step 1: The program coordinator identifies eligible men aged 50–70.
- Step 2: The program coordinator mails the above materials (e.g., NCI Decision Aid Letter) to participants or hands them out in person, depending on the setting.
- Step 3: The program coordinator helps participants if they have trouble accessing or using the website by providing the Instructions for Using the Prostate Cancer Decision: Making the Best Decision Tool, Internet Access Locations, or Troubleshooting for Web Decision Tool sheets.
